

## **SALEM TENNIS AND SWIM CLUB**

### **WAIVER AND RELEASE OF ALL CLAIMS AND LIABILITY**

Salem Tennis and Swim Club (STSC) is committed to the health and safety of our members and staff during the COVID-19 pandemic. Therefore, we have developed a temporary Prevention and Social Distancing Plan to accomplish our commitment to prevent the spread of the COVID-19. The complete plan is available for your review upon request. Additionally, we are initiating a Pilot Program that you may participate in to ensure the plan is effective.

Participating in the Pilot Program has some degree of associated risk. In consideration of being allowed to participate in the Pilot Program offered by STSC of which I voluntarily request the right of participation, I hereby state and acknowledge as follows:

1. I voluntarily request the right to participate in activities offered and understand and appreciate the risk of the activities in which I desire to participate and do acknowledge the risk of personal illness as well as death.
2. Even with such understanding and appreciation of the risk, I still desire to participate or have my minor children participate, and do hereby fully and irrevocably release and forever discharge, STSC, individually and in capacity as its members, managers, directors, employees, agents, and all owners and lessees of the property from any and all legal claims, demands, actions, losses, and / or legal liability of any kind of nature or description resulting from such activities sustained by me or my minor children, and further covenant to hold all said parties harmless.
3. I do hereby personally assume all risks which may be associated with such activity. I understand and acknowledge that this is a legal and binding contract and by affixing my signature hereto acknowledge that I have read and fully understand the waivers and releases contained herein.
4. Members only can play during the Pilot Program. No guests are allowed in the facility for any reason.
5. I do hereby agree to follow Member Responsibilities listed here:
  - Take their own temperature prior to coming to STSC and stay home if you have any of the following symptoms that may indicate you have COVID-19:
    - Cough
    - Shortness of breath or difficulty breathing
    - Fever
    - Chills
    - Unusual muscle pain
    - Sore throat
    - New loss of taste or smell

- This list is not all possible symptoms. Other less common symptoms have been reported, including gastrointestinal symptoms like nausea, vomiting, or diarrhea.\
- Players must have reserved court times and all parties playing must be listed on the court reservation.
- Players will be required to wear a mask when inside the facility except when actually on the court.
- Once they arrive at Salem Tennis and Swim Club, they must wash their hands immediately upon arriving at STSC
- Players will play only with their selected four players.
- Players must use their own tennis balls, the same can of balls can be used during the match by all players. Balls may be brought from home or purchased at the club.
- A new can of balls will be used each match
- People will be stay at least six feet apart to maintain social distancing.
- Players should stay on their side of court and avoid changing ends.
- Players shall not walk behind or touch “Green Curtains”, this includes walking to or exiting courts, retrieving balls etc.. When tennis balls become trapped behind Green Curtains the players must use their racket and or feet to retrieve the ball.
- Follow USTA **COVID-19: Playing Tennis Safely** published April 22, 2020.
- Any player that develops a fever or flu like symptoms must notify Salem Tennis and Swim Club. Once notified our Covid-19 safety liaison will notify the CDC.
